We've won two Apex Awards for Excellence. Sponsored by the editors of Writing That Works: The Business Communications Report, the 19th-annual awards are based on excellence in "graphic design, editorial content and the success of the entry in achieving overall communications effectiveness and excellence":

- One award came to us for our profile of State Bar President Jim Smith, published in July/August 2006. Titled "A Sense of Place," it mapped one man's amazing life tra-
- A second award was given for the design of what we call a "spread," the opening two pages for a major feature article. The spread opened our November 2006 series of stories in our "Special Focus on Eminent Domain."



We also won a Communicator Award, which is especially gratifying. Not only did we land an Award for Excellence (the highest award possible) in this international awards program recognizing "creative excellence in the communication field." But we were recognized for our March 2005 feature story "The Seven Deadly Judges." That piece was written by former Editorial Board Chair Randall Warner, who has long been a friend to the magazine

Finally, the design efforts of our Art Director, Karen Holub, were recognized for our January 2007 issue focused on "Immigration: The Borders of
