### **AUGUST MEETING REVIEW**

The State Bar of Arizona Board of Governors held a regular meeting on Aug. 2, 2013, in Flagstaff, Ariz., in conjunction with the Board of Governors Retreat. To see the complete minutes go to www.azbar.org/aboutus/leadership/ boardofgovernors/minutes.

- ▶ President Whitney Cunningham called the board meeting to order at 10:35 a.m.
- ▶ President's Report
- ▶ President Cunningham stated he had attended the Arizona Iudicial Council meeting.
- ► He will attend the National Conference of Bar Presidents during the ABA Annual Meeting.
- ▶ President Cunningham encouraged board members to know their respective elected officials and to invite them to coffee or lunch to get to know them better.
- ► Changing the board meeting schedule from nine to six meet-

ings per year means action on matters will be taken at the same meeting they are presented, so it is important to be prepared ahead of time. The decision-making process will no longer include the introduction of a business item one month and taking action the next, except in certain cases.

#### ► CEO Report

- ▶ John Phelps reported that CLE by the Sea in San Diego and the annual Convention were both a great success.
- ▶ Implementation of a new case management system has an aggressive schedule, with deployment scheduled for October.
- ▶ President Cunningham completed appointments to the 28 standing committees. Almost 250 volunteer applications were received.
- ► The financial formula model

- prepared by CFO Kathy Gerhart and Accounting Manager Martín Gaxiola will be a very valuable tool to use in the future as Bar programs and services are reviewed.
- ► Lisa Deane, Chief Member Services Officer, put together a webinar titled "Violence Against Attorneys" that will be offered to legal professionals throughout the United States. It will air on August 20. The State Bar is taking a lead nationally in this area.
- ► Yarnell Fire—The State Bar is part of Arizona's Emergency Response and Recovery Plan. State and national representatives worked together to respond.
  - ► Special thanks to board member Alex Vakula, who practices in that part of the state and worked to bring together volunteer lawyers in

- a needs assessment.
- ▶ Work is progressing on the annual Directory.

#### ► Consent Agenda

- ▶ President Cunningham stated that item 4.e—"MCLE Committee Policy Change"—was withdrawn from the consent agenda for further study. Nothing else was removed, and the board voted unanimously to approve the remainder of the items as submit-
- ► ABA Commission on Ethics 20/20 Proposed Response
- ► On behalf of the board Rules Committee, Patricia Sallen, Director, Special Services and Ethics - Deputy General Counsel, reviewed and summarized the draft correspondence prepared for President Whitney Cunningham's signature. A letter addressed to Chief Justice Berch is in response to her request for the Bar's input on the proposed changes to non-

member and admissions-related Model Rule changes emanating from the ABA commission. The Board of Governors unanimously approved the draft response.

#### ► ABA House of Delegates Resolution 108 and Indiana State Bar Association Resolution 10B

- Ms. Sallen stated that these are two competing resolutions and very controversial regarding the ABA Model Code of Judicial Conduct.
- ▶ ABA Delegate Jim Smith suggested that the State Bar remain neutral regarding these resolutions and also stated that they are likely to be withdrawn from the ABA House of Delegate's agenda. The Chief Justice's Conference Committee voted to recommend the withdrawal of both resolutions

#### ▶ Program Review Committee

- ➤ The board voted unanimously to create a Program Review Committee with Immediate Past President Amelia Craig Cramer as Chair.
- The committee will review all the programs/services of the Bar as well as examine revenue-generating ideas.
- ► The committee is scheduled to report at the October board meeting.

#### ► CLE Task Force

► The board voted unanimously to have the Task Force on CLE Administration, chaired by Jeff Willis, include in its charter the pros/cons of CLE pre-certification.

#### ▶ Board Composition

- ► The board voted unanimously to file a petition for Supreme Court Rule 32 to change the status of the three law school deans from ex-officio to full voting members of the board, with the stipulation that the voting privilege is for the Dean and not his/her designee or representative.
- ▶ October 25 Board Meeting Discussion—It was agreed to also examine the board's composition under Rule 32 (number of members, staggered terms, etc.) will be discussed.

### ► Association of Corporate Counsel (ACC) Dinner

- ▶ General Counsel John Furlong reminded those present that the Association of Corporate Counsel (ACC) is holding an annual awards banquet in January 2014 at the Ritz-Carlton Phoenix and that the State Bar agreed to co-sponsor the event.
- ➤ The board previously voted to approve the sponsorship with some conditions, which were met by the ACC.
- ► The contract also was provided for the board's information.

# ► Proposed Amendments to the State Bar of Arizona Bylaws

- ► Mr. Furlong reviewed all the proposed changes to the bylaws, which are scheduled to be voted on at the October 25 meeting:
- ► Change Rule number from 31 to 32
- ► Change the Bar address from Suite 200 to 100
- ▶ Technical changes
- Under 8.02(C), First Vice President duties changed to reflect the changes in the discipline system
- ► Change the Long Range Planning Committee

- to "Strategic Planning Committee"
- ► Change Executive Director to "CEO/Executive Director"
- Added under 10.02 Notice of Annual Meeting to include using electronic means.
- ► 11.01, The number of regular board Meetings is modified from nine regular meetings to a minimum of six regular meetings each year with the schedule to be determined by the President
- Under 14.01, written notice for any proposed bylaw amendments must be given 30 days in advance "by mail or electronic means"

#### ▶ Finance Committee

- ▶ CFO Kathy Gerhart reported for the six months ending June 30, 2013, the Bar's income statement generated a surplus of \$745,000, excluding Sections, Access to Justice distributions, and professional services for the Andrew Thomas case.
- ►Surplus year-to-date is \$310,000 more than budget. This is due to \$67,000 less in revenues and \$377,000 less in expenses. Cash and cash equivalents increased \$2,476,000, which includes principal payments of \$1,100,000 on the line of credit.
- ▶Balance sheet reflects a net worth/net assets of \$9.041.000.


Northern Arizona University. A past president of the State Bar of Arizona, he served as the NAU commencement speaker at its May 2013 ceremony.


