BOARD OF GOVERNORS SEPTEMBER MEETING REVIEW

- President Jim Smith called the meeting to order at 8:30 a.m., and the Board went into Executive Session until 9:10 a.m.
- The Discipline Oversight Committee presented information on proposed changes to the Discipline Rules by Dan McAuliffe, Chair, and Robert Van Wyck, Chief Bar Counsel.
- Guest speakers on the proposed Discipline Rule changes included members Mark Harrison and Nancy Greenlee.
- ABA House of Delegates Report—Ernest Calderón, ABA Delegate, provided the official ABA Daily Journal from the August Assembly held in Honolulu and summarized its content.
- Arizona College of Trial Advocacy—Peter Collins, Jr., Chair of the Trial Practice Section Executive Council, summarized the 2006 Arizona College of Trial Advocacy and the plan for the 2007 program to be held July 24-28 at the Black Canyon Conference Center in Phoenix.
- Appointments Committee— Ray Hanna, Chair, summarized the current openings and provided the recommendations of the Appointments Committee to the Board for the following:
 - Arizona Supreme Court Committee on Character and Fitness (Public Member Openings)—The board voted to forward the names and applications of the following public members to the Arizona Supreme Court for its consideration to fill the two non-lawyer positions on the

committee: Michael Boyd, Kristina Fredericksen, Harold Holmes, Wanda Moore, Ben Tousely.

- Arizona Supreme Court Committee on Character and Fitness (Lawyer Openings)—The board voted to submit the names and applications of the following members to the Arizona Supreme Court for its consideration to fill the three lawyer positions on the committee: Richard Gordon, Ms. Frankie Jones, Patricia Nigro, Kathryn Pierce, Viola Romero-Wright, Mr. Cary Sandman, John Tuchi, Christopher Whitten, Ms. Laura Zeman
- Arizona Supreme Court Committee on Examinations (Lawyer Opening)—The board voted to refer this matter back to the Appointments Committee, directing that the process be reopened and the vacancy be readvertised. The Appointments Committee report on this matter is calendared for the board's October 20 meeting.
- Client Protection Fund Board of Trustees (Lawyer Opening)—The board voted to reappoint Geoffrey Sturr to the Client Protection Fund Board of Trustees to serve a second, but final, term.
- Consent Agenda—The board approved the Consent Agenda consisting of the Revised June Minutes, July Minutes, Resignations of Members in Good Standing, Alternative Dispute Resolution Section Bylaws, Updated lists of MCLE Suspensions, and Reinstatements of members suspended for non-compliance with Rule 45, ARIZ.R.S.CT. Arizona Civil Rule 74(a) was removed from the Consent

Agenda.

- Teresa Schmid, Executive Director, gave highlights from her ED Report.
- Larry McVey, Chief Financial Officer, stated that his summaries for June and July financial information were written and asked for questions from the Board.
- The Finance Committee recommended and the board approved the 2007 Budget Guidelines for staff as directed from the Financial Policies Manual, p. 5, paragraph (h).
- Rules Committee—The Board unanimously approved the recommendations of the Rules Committee and the Civil Practice and Procedure Committee that the Petition to Amend ARIZ.R.CIV.P. 7.1(e), governing motions for recon-

sideration, be filed with the Supreme Court as distributed to the Board.

- Lunch Presentation—Juan Carlos Flamand was presented a gift from the board for his accomplishment of receiving the high score on the May 2006 Bar Exam.
- Special Recognition—The board presented a gift of appreciation to Matthew Silverman, Senior Director of Communications, who after eight years of dedication and service to the Bar will be leaving to take another position.



He was born May 8, 1949, in Bisbee, Arizona, to James E. and Maggie Lu Brophy. Mike leaves behind

his wife of 32 years, Marilyn Pritchard Brophy, and two sons, Tom (Luz) and Matt.

Mike, a third-generation Arizonan, graduated with highest honors from the University of Arizona in 1971. In 1977 he received his law degree from Arizona State University and joined the Ryley Carlock & Applewhite law firm. He built the firm's natural resources practice, was the longtime practice group leader, and served as the firm's managing partner in 2003 and 2004.

He was a nationally renowned water and environmental lawyer with many professional achievements. He served as the Arizona Representative to the Western States Water Council from 1991 to 2002, and was elected Chairman from 2000 to 2002. Mike was also the Chairman of the Water Policy Committee for the Greater Phoenix Chamber of Commerce. He was perhaps most proud of his work in connection with negotiating and securing the enactment of legislation by the U.S. Congress involving water rights and settlements for the Gila River, Salt River Pima–Maricopa, Fort McDowell and Ak-Chin Indian Communities, and the San Carlos Apache Tribe.

Mike was a man of few words and great heart who valued honesty, courage and loyalty above all other traits. He profoundly believed in service and commitment to others. Mike was a member of the United Way Tocqueville Society and a great supporter of Brophy College Preparatory. He was devoted to his family, friends and Catholic faith. Mike's passion for reading, art, travel, fishing, hunting and hiking yielded many friends and admirers. He was a quiet, gentle man and a fierce advocate who never did anything by halves. He will be deeply missed by those who knew and loved him.
