Specific Bequests of a Vehicle:

I give **my 2004 Honda Civic to my spouse**. If **my spouse** is not living upon my death, the specific bequest shall lapse and be distributed to my issue, per stirpes. If I have no then living descendants at my death, this specific bequest shall lapse and be distributed according to the terms of the remainder of my estate. This specific bequest shall control over any personal property memorandum as set forth in part A above.

I give **my 2004 Honda Civic to my spouse**. If **my spouse** is not living upon my death, the specific bequest shall lapse and be distributed to my then living children. If I have no living children at my death, this specific bequest shall lapse and be distributed according to the terms of the remainder of my estate. This specific bequest shall control over any personal property memorandum as set forth in part A above.

I give **my 2004 Honda Civic to my spouse**. If **my spouse** is not living upon my death, the specific bequest shall lapse and be distributed to my then living grandchildren. If I have no living grandchildren at my death, this specific bequest shall lapse and be distributed according to the terms of the remainder of my estate. This specific bequest shall control over any personal property memorandum as set forth in part A above.

I give **my 2004 Honda Civic to my then living children**. If I have no living children at my death, this specific bequest shall lapse and be distributed to **my alternate beneficiary**. If **my alternate beneficiary** is not living, this specific bequest shall lapse and be distributed according to the terms of the remainder of my estate. This specific bequest shall control over any personal property memorandum as set forth in part A above.

I give **my 2004 Honda Civic to my issue, per stirpes**. If I have no then living descendants at my death, this specific bequest shall lapse and be distributed according to the terms of the remainder of my estate. This specific bequest shall control over any personal property memorandum as set forth in part A above.

I give **my 2004 Honda Civic to a class consisting of my nieces and nephews**. If there are no then living class members, this specific bequest shall lapse and be distributed according to the terms of the remainder of my estate. This specific bequest shall control over any personal property memorandum as set forth in part A above.

I give **my 2004 Honda Civic to another individual**. If **another individual** is not living upon my death, this specific bequest shall lapse and be distributed to **my alternate beneficiary**. This specific bequest shall control over any personal property memorandum as set forth in part A above.

I give **my 2004 Honda Civic to a named charity or charities**. This specific bequest shall control over any personal property memorandum as set forth in part A above.

I give **my 2004 Honda Civic to these named individuals in the following distribution:**

If a beneficiary named above predeceases me, his or her share shall be distributed to his or her issue, per stirpes.

Specific Bequests of Cash:

I give **five thousand dollars (\$5,000.00) to my spouse**. If **my spouse** is not living upon my death, the specific bequest shall lapse and be distributed to my then living children. If I have no living children at my death, this specific bequest shall lapse and be distributed according to the terms of the remainder of my estate. This specific bequest shall control over any personal property memorandum as set forth in part A above.

Specific Bequests of Real Property:

I give **all of my interest in the real property, or any successor real property, located at 123 Main Street and legally described as**

**Lot 18 of Fictional Residential Subdivision, Pima County, Arizona,
according to the Map of Record in the Office of the County Recorder of
Pima County, Arizona, recorded in Book 18 of Maps at Page 18**

to my spouse. I understand that if I own any interest in the real property at my death and I have recorded a Beneficiary Deed, then the property ownership will vest at my death to my beneficiaries as set forth on the Beneficiary Deed and not to any devisee as set forth in this Last Will and Testament. In addition, if the property is titled in joint tenancy with right of survivorship or community property with right of survivorship, the property will pass by operation of law and this clause in my Last Will and Testament shall lapse. If **my spouse** is not living upon my death, the specific bequest shall lapse and be distributed to my issue, per stirpes. If I have no then living descendants at my death, this specific bequest shall lapse and be distributed according to the terms of the remainder of my estate. This specific bequest shall control over any personal property memorandum as set forth in part A above.

Specific Bequests of Tangible Personal Property:

I give **my badge to my spouse**. If **my spouse** is not living upon my death, the specific bequest shall lapse and be distributed to **another individual or individuals**. If **another individual or individuals** is not living at my death, this specific bequest shall lapse and be distributed according to the terms of the remainder of my estate. This specific bequest shall control over any personal property memorandum as set forth in part A above.

Distribution of Remainder of Tangible Personal Property

The remaining tangible personal property not distributed as set forth above shall be distributed **to my spouse**. If **my spouse** is not living upon my death, the specific bequest shall lapse and be distributed to my issue, per stirpes. If I have no living descendants at my death, this specific bequest shall lapse and be distributed according to the terms of the remainder of my estate.

The remaining tangible personal property not distributed as set forth above shall be distributed **to my spouse**. The remaining tangible personal property not distributed as set forth above shall be distributed **to a named charity or charities**.

The remaining tangible personal property not distributed as set forth above shall be distributed **according to the terms of the remainder of my estate**.

Cost to Distribute Estate Property

The reasonable costs of protecting, appraising, packing, storing, shipping, cleaning, delivering and insuring my personal effects, including costs incurred before my Personal Representative was officially appointed to this position by the Probate Court, shall be paid as an expense of administering my estate.

Nomination of Personal Representative
