representatives, included Arizona's Constitution, state and federal government, state executive and judicial authority, federal and state relations with Native American nations, limits on state legislation and state criminal law issues.

- ► Helen Perry Grimwood (chair of the Board's Rules Review Committee), Sally Wells (chair of the Criminal Practice and Procedure Committee), Kent Cattani (Attorney General's Office) and Julie Hall (a criminal defense attorney) provided input regarding proposed amendments to the death penalty-related rules. The Board voted to adopt as the State Bar's position, and to forward to the Arizona Supreme Court, the recommendations and comments of the Criminal Practice and Procedure Committee with regard to the following: Rules of Criminal Procedure 8.2, 15.1, 15.2, 15.9 Issue 2, 18.1, 18.6, 19.1, 20, 24.1, 26.2, 26.3, 26.9 and 26.10. The Board also voted to forward to the Supreme Court for its consideration the Committee's comments and proposed amendments regarding Rule 13.5, 15.9 Issue 1, 18.5 and 23.2, ARIZ.R.CRIM.P.
- ▶ Roger Curley, representing the Probate and Trust Law Section, summarized the section's version of the Uniform Trust Code (UTC) for adoption in Arizona. The proposal does not affect tax provisions. The Board voted to support the section's request that the State Bar recommend the adoption of the UTC to the Arizona Legislature.
