

BOARD OF GOVERNORS

MARCH MEETING REVIEW

Below are highlights from the March 17, 2006, State Bar Board of Governors meeting. Meetings typically are held monthly at the Arizona Bar Center in Phoenix. To see the complete minutes, go to www.myazbar.org/AZBarlnfo and click on "Board of Governors."

- President Helen Perry Grimwood called the meeting to order. President Grimwood stated that the Navajo Nation would be presenting first on the agenda.
- ► The board voted to have the President sign a letter on behalf of the board to federal lawmakers supporting the Navajo Nation's request for funding of a Navajo Nation Supreme Court facility.
- ► President Grimwood announced that the Arizona Supreme Court has appointed Virginia Herrera-Gonzales as an At-Large Member of the State Bar Board of Governors.
- President Grimwood reported on the Board of Governors Election in District 6 (Maricopa County). It is a two-year term. Candidates are Larry Coben, Tom Crowe, Leslie Hall, Scott Maasen, Penny Willrich and Robert Young.
- ► President Grimwood reported that David Rosenbaum and Judge Rachel Carillo have been named as co-chairs of the Landlord Tenant Task Force.
- ► The board approved the draft response letter to be sent to the President of Los Abogados and to the Committee on Minorities and Women in the Law (CMWL) with a copy to the Appointments Committee.
- Dues/MCLE Restructuring Petition—President Grimwood reported on the meeting with the Senior Lawyers, including Frank Lewis, speaking on their behalf, and Board members Alan Bayham, Ray Hanna, Dan McAuliffe and Richard Coffinger. The Senior Lawyers in attendance voiced their displeasure with the dues increase and CLE requirement. No action was taken by the board on the draft proposal submitted. Comments to the existing proposed rule are due May 22,

- 2006. The Supreme Court will act in September. After lengthy discussion, the matter was tabled.
- Paige Martin, AWLA representative, reported on the work of the organization and upcoming events.
- President Grimwood presented information about the ABA's diversity initiatives.

BOARD OF GOVERNORS MEETING HIGHLIGHTS

Landlord Tenant Task Force

David Rosenbaum and Judge Rachel Carrillo have been named cochairs of this Task Force, which is a well-balanced slate of task force members, including members of the judiciary, tenant advocates and multi-family housing representatives. The task force will study the eviction process in Arizona and, if appropriate, propose Uniform Rules of Procedure for Forcible Entry and Detainer Actions under the Arizona Residential Landlord Tenant Act.

Board of Governors Election

Active State Bar of Arizona and judicial members in District 6 (Maricopa County) were eligible to vote in the election for one Board of Governors seat from District 6. The candidates for the two-year term were:

Ballots were due back at the State Bar no later than May 19.

Court Appoints New Board Member

The Arizona Supreme Court has appointed Virginia Herrera-Gonzales as an at-large member of the State Bar Board of Governors. Among the 26 voting members of the Board, the court appoints three at-large members. Herrera-Gonzales will serve through June 2008.

New Award for Criminal Law Prosecutor

The Board approved the creation of a new State Bar award to honor a criminal law prosecutor who has worked tirelessly to advance the principles of criminal justice by representing the public's interest with fairness, integrity, tenacity, creativity, brilliance and, above all, professionalism. The award is name after Michael C. Cudahy, former chief of the Criminal Division, Arizona Attorney General's Office.

Navajo Nation Supreme Court

The Board approved sending a letter to federal lawmakers supporting a request for their need to build a Navajo Nation Supreme Court facility.

Sandweiss Named to Conflict Case Committee

The Board approved the reappointment of David Sandweiss to a second term on the Conflict Case Committee, whose members investigate and prosecute disciplinary cases involving members of the State Bar Board, Bar staff, a Supreme Court Hearing Officer or member of the Court's Disciplinary Commission.

- reviewed the January 2006 financial statements included in the board materials.
- Ray Hanna, Chair of the Finance Committee, reviewed the following requests:
 - The board voted to approve the Finance Committee's recommendation to approve the donation of used furniture from the Tucson office when it relocates to the Arizona Center for Disability Law.
- ▶ Audit Committee—Frank Barriga, Chair, reported on the Audit Committee meeting with auditors from Miller Allen & Co. This meeting was the planning meeting before the audits begin. Upon completion of the audits, the auditors will meet with the respective boards of the State Bar and the AzFLS&E again to present and report on the audit findings. The next project for Miller Allen & Co. is the audit of the Client Protection Fund.
- Chief Bar Counsel Report—Robert Van Wyck reported on the oral argument and a summary on the *King* case. Justice Scott Bales was not present for Mr. Van Wyck's report.
- ➤ The board approved the consent agenda to include Approval of Reinstatements and Notice of Deceased Members. The board approved the amended minutes of February 17, 2006.

Liaison Reports

- ➤ Young Lawyers Division, Jeff Jacobson, President, reported on the very successful Wills for Heroes program, which has written 577 wills through the program. The program has partnered with the Arizona Asian American Bar Association (AAABA). Quarles & Brady was the first large firm to encourage their attorneys to participate, and the YLD anticipates other large firms will participate.
- Arizona Asian American Bar Association— No report.
- ▶ Amelia Cramer, Chair of the Tucson Building Task Force, reported on the February 3 meeting of the Task Force which made an offer on the 70-80 Franklin property. Ms. Cramer reported the Franklin property was no longer an option and that the Task Force was working on extending the current lease and continuing to look at additional new space.
