### DISCIPLINE ON THE WEB FINALIZED

The State Bar of Arizona Board of Governors approved a final plan on how lawyer discipline information will be displayed on the Bar's Web sites.

At its June meeting, the Board voted to publish the information via "Find a Lawyer" and "Member Finder" on [www.azbar.org](http://www.azbar.org) and [www.myazbar.org](http://www.myazbar.org), respectively.

The Board voted not to have Web publication of informal reprimands, diversion orders, formal complaints filed by the State Bar, or probable cause orders. However, that information remains public, pursuant to Supreme Court Rule, and it can be accessed via telephone or by inspection of State Bar public records.
