# Shining Stars in Arizona

In June, the Arizona Foundation for Legal Services & Education recognized 50 "shining stars"—attorneys who have given tirelessly to provide free legal services to low-income clients. At a reception at the Phoenix home of George & Ronnie Lyons, Arizona Chief Justice Charles E. Jones gave them their awards as the "Top 50 Pro Bono Attorneys in Arizona."

These individuals give their time and legal expertise outside of their "regular" job to clients of the Volunteer Lawyers Programs of Community Legal Services, DNA-People's Legal Services, the Florence Immigrant & Refugee Rights Project and Southern Arizona Legal Aid.

All types of assistance are provided by these volunteer lawyers—from advice to extended representation—in all areas of the law—bankruptcy/debt collection, landlord/tenant, home ownership, family matters, estate planning, to name just a few.

Thabet Khalidi, one of the honorees from Tucson, explained why he provides volunteer legal assistance: "The fact of the matter is that we are a privileged profession with an opportunity to do some good as a means of giving back to society all that it has given us. None of us would be where we are today without the help of countless others. The only way to repay these kindnesses is to help others."

Volunteer attorneys come from everywhere, as seen by the range of legal positions held by the honorees. Twenty of them are solo practitioners. Others work in a variety of firms, for the Arizona State Senate, the Arizona Title Agency and the ASU School of Law.

2003 is the third year that the Arizona Foundation for Legal Services & Education has given this award to 50 attorneys. The Foundation's President, Debbie Hill, expressed her appreciation for the honorees' work, "These volunteer attorneys truly are shining stars and shining examples of the difference our profession can make. We salute the Top 50 Pro Bono Attorneys in Arizona."
